Council Boland stated she is not getting paid by the airport, but she is a strong supporter of the Stephenville airport, and she will be promoting the airport as Sunwing is committed to fly into Stephenville. Acknowledging its come home year, and hundreds of people have booked to fly into Stephenville this summer and it would be devastating if we didn't continue to support the airport this summer.
