#### **UNFINISHED BUSINESS**

## **Stephenville Court House**

Mayor Rose made comment that he was interviewed by CBC regarding the decision of government to relocate the courthouse to Stephenville Crossing, he also stated correspondence has been sent to government officials expressing our disappointment and concerns. Councillor Aylward remarked it pits one community against another and it's again renovating an old building not suited to the specific needs; making reference to the renovation of the Bay St. George Medical Clinic. She also noted the past government Tom Marshall promised a courthouse to be built in Stephenville. Deputy Mayor Fowlow pointed out that we support Stephenville Crossing, however the decision to relocate is not logical when considering the users of the courthouse. Mayor, Deputy Mayor and Councillor Aylward made reference that council advocated to have the courthouse accessible for all users, and now it's going to be accessible but taken out of the community. It was queried if they advocate the Bay St. George Medical Centre to be better accessible will government decide to relocate this also? Councillor Tiller stated the courthouse will be accessible for mobility, however he questioned whether the location is making it more inaccessible for more people.

#### **NEW BUSINESS**

## **Councillor Aylward**

Councillor Aylward referenced members of council meet with David Palmer, Manager of Recruitment Services for Western Health and recruitment efforts is seeming positive.

Community is lacking media presence for accurate information sharing, In response the Mayor suggested a community radio for marketing and communication. Councillor White stated this would be valuable way to reach the senior population who do not rely on technology. Councillor Tiller acknowledged there is interest in the community to support this idea. Deputy Mayor Fowlow and Councillor Boland agreed that the residents should have to access to community information but also share information related to town processes and actions. Deputy Mayor also stated council is working towards a communication strategy to include website and social media presence.

## **Mayor Rose**

Acknowledged Nomad Stages is continuing to fundraise for Ukraine with an online auction; currently \$30,000 has been raised. The Association for New Canadians has reached out to us and will we continue to work with them on Ukraine refugees.
