# Amendment Western Health Recruitment and Retention Program

Motion No. 22-244 White/Aylward

It was the recommendation of the Finance committee that the Town of Stephenville approve to Amend Western Health Recruitment Program retroactive to May 20, 2022. To include the following changes:

- 1. Approved employment contract from Western Health and/or Medical Clinics is required. To be eligible for the benefits the physicians is to practice in the Town of Stephenville for a minimum of two (2) years, full-time commitment of service:
- 2. Approval to prorate the compensation and benefits if commitment of service is between eighteen months and twenty-four months; benefits are prorated based on two years of service; all other conditions are applicable. Longer commitment of service is not applicable to be prorated, the maximum benefits payable will be 24 months.
- 3. Vehicle Lease /Purchase Reimbursement \$800.00 Month Due to inventory of local dealerships the lease/purchase vehicles outside of Stephenville shall be approved; Current lease owners will be eligible to be compensated for the remaining lease up to a maximum of twenty-four months. Council has the right to change these conditions once the local dealership inventory improves.
