# **Request for Grant- Stephenville Airport Corporation**

Motion No. 22-73 Tiller/Aylward

It was the recommendation of the Finance Committee that the Town of Stephenville give a grant to the Stephenville Airport Corporation in the amount of \$50,000. \$ 30,000 allocated for operations, \$20,000 for WASCO February contract fees.

Councillor Tiller questioned the ownership of the airport; as his research provided conflicting information. He stated the Dymond Corp website declares they have acquired the Stephenville Airport and it's been renamed the Stephenville Dymond International Airport. The Stephenville Airport Corporation website indicates to follow the Dymond Group of Companies on LinkedIn; which connects to the Stephenville Dymond International Airport, which claims ownership of the Airport.

The Mayor, as council liaison on the airport board responded. The airport board and the Dymond group co-signed a legal document in September that gave authority for the Dymond group to purchase the airport, based on the terms of a purchase agreement. The purchase agreement is being negotiated as the lawyers representing each continue to work on file. Currently the airport board authority is the legal operating entity. Carried Unanimously

# Public Meeting of Council March 10, 2022 Mayor Rose

Mayor Rose recognized Qalipu has hired Paul Pike for the position of Cultural Outreach Officer, and this is an important position for our region.

Western Health Update

- Council met with Dr. Rashleigh and Teara Freake of Western Health, they confirmed a surgeon will arrive in couple weeks and the possibility of family physicians joining Bay St George Medical Clinic.
- We are working with Western Health and may create a partnership for a new medical clinic. Western Health is inquiring with government on procurement process.

Council has discussed moving forward with Preliminary Engineering for Long Term Health Care Facility on the property behind the hospital.

Letters has been sent to the Premier and the Ministers outlining we are upset that the Stephenville Airport was the only airport excluded from government funding announcement.

# **Councillor Aylward**

Welcomed the New Town Manager, Colin Maddock.

Councillor Aylward expanded on the meeting with Dr. Rashleigh and Teara Freake of Western Health noting:

- Western Health has applied for funding to renovate the housing units in Stephenville.
- Western Health is working toward Collaborative team approach to health care, combining Physician, Nurse Practitioner, Physiotherapist, etc.
- She requested an update on dialysis equipment that the foundation raised money to purchase.
- She referenced the importance of Western Health Management communicating with the doctors.

# **Deputy Mayor Fowlow**

Acknowledged that council will continue to lobby to government on accessibility at the Court House.
