However, he recognized there is a health care crisis with family physicians. After thirteen months of requesting, there is a meeting scheduled with western health recruiters. He stated this is mismanaged, and clearly people are not doing their job. We have lost nine family physicians, and as a municipality we must take a leadership role.
