Request for Assistance, Stephenville Dome Committee

Councillor Felix

Councillor Felix as council representative on the Stephenville Dome Board Committee he provided an update. He stated the Manager of the Dome Ross White and the boards chair both resigned. The dome committee will require assistance in the interim until a manager is hired. Mayor Rose inquired if notice was provided, in response Councillor Felix indicated one-week notice was given. Councillor Felix indicated due to Covid -19 ice time has been restricted and the dome hours of operations has been reduced, which has affected users' groups. He stated the Dome is operating under the regulations of the province and minor hockey and the figure skating has their own rules to follow also.

- He thanked Ross White for his 35 years of service and his commitment to recreation.
- Suggested the stadiums commission board members should include representation from the user's groups.
- He stated he received an inquiry from a parent who stated she was not allowed to stay with her four-year-old child during a skating program, Councillor Felix responded indicating the parent must have misunderstand, one parent can stay with a child that is under twelve years of age for the programs.
- Carolina Bridge has received maintenance, and contract to repair will commence in 2021.
- The senior Bus has arrived, and the program should be implemented in December.

He inquired if severance will be paid to Ross after 35 years' service. Councillor Felix responded stating, there was no contract, therefore no severance. Councillor Aylward reacted and stated Brenda Martin received severance and Ross should be compensated also. Councillor Felix indicated he will forward the request to the board and will provide an update to council.

She thanked Ross White for his years of service with the Stephenville Dome and the Beautification Committee; indicating he was always cooperative and efficient and deserves compensation for all the years he worked.
