UNFINISHED BUSINESS

Councillor Aylward

inquired if the letters requesting the Ministers to meet with council were completed, in response the Mayor indicated the letters are with staff for completion.

Council needs to lobby with other municipalities to have a highway from Port Aux Basque to St. John's.

NEW BUSINESS

Mayor Rose

Mayor Rose stated the Town of Stephenville has been recognized by National media, The Globe and Mail has referenced the Towns Recruitment and Retention package for Health Care.

He thanked the Appalachian newspaper for covering the story about a senior that was injured at the government service building and I have followed up with Minister Abbott since the incident.

Councillor White

Councillor White expressed concerns over the location of the Playground at Blanche Brook Park. Stating due to high traffic at McDonald's, traffic from functions held at the park, crossing drive- thru of McDonalds, growth of the town will contribute to the safety risk of children trying to access the playground.

In response Mayor Rose stated we will request staff to provide council with an overview of the file. Also suggesting the town can consider other means to increase safety in this area, including reducing speed limit, speed bumps, sidewalks, and increase parking.

Councillor Tiller

Councillor Tiller inquired if the Dymond group, Mayor or Councillor Aylward contacted the provincial government regarding the effects that the Health Accord will have if the town grows as suggested by the Dymond group? He noted the Health Accord will bring our hospital to level 1 (glorified clinic). He also inquired if at level 1 can the hospital return to a full capacity hospital and when if major growth do happen in the town. In response, Mayor Rose stated we are not prepared to lose any services from the hospital we are a regionally center and we will contact the MHAs, Ministers and the Premier. The Health Accord has a lot of recommendations and it's a 6–7-year plan, however we need start lobbying now.

Councillor Aylward noted Western Memorial Hospital cannot accommodate our services, not even when the new hospital is built.

Councillor Tiller inquired if Christmas on Main Street was being considered this year? In response Mayor Rose stated yes the event is being planned.
