Under the Authority of Section 16 of the Urban and Rural Planning Act 2000, the Town Council of Stephenville adopts the Stephenville Development Regulations Amendment No. 13, 2019 which includes:

Proposed Rezoning:

• Rezone two 0.4-hectare parcels of land (0.8 hectares in total) in the vicinity of Hillier Avenue from Comprehensive Development Area-Residential (CDA-R) to Rural (RU). This will allow for development of a maximum of two residential dwellings.

• Condition to Amendment - As a condition to this amendment, council will not permit any drilled groundwater well(s) to be constructed as a water source for the two residential properties covered by the amendment.

This amendment is proposed to comply with Amendment No. 7 to the Stephenville Municipal Plan Conditions to the amendment corresponds to the conditions outlined in proposed Municipal Plan Amendment No. 7, 2019
