Councillor Felix

The results of the budget survey are now available on the Town's website. He stated there were no big surprises in how the tax payers responded. Council's expenditures and budgets are conforming to the feedback received; although as elected officials distinct decisions will be required. The number one issue delivered from the survey is pot holes and road improvements. He welcomes new technology to extend the season for pothole repairs, and the Town should be looking into demanding higher quality asphalt also to extend the life of the roads.

Mayor Tom Rose

He attended the MNL western regional conference is Rocky Harbour, along with councillor Mike Tobin. The meeting was informative and educational and he recommended all council to attend one of the meetings during the year. It's an opportunity to network and to develop and grow our town. Some of the key topics discussed were: Federation of Canadian Municipalities, conflict of interest, MNL website, cannabis, and Waste Management.

He stated it's time for the Town of Stephenville to provide leadership and action for a level 3 - long term care facility. He recommended requesting Honourable John Haggie, Minister of Health and Community Services to meet with council to discuss this opportunity for the Town.

Stated the Urban Municipalities Committee (UMC) of MNL now comprises of 23 communities, and the next meeting is scheduled for June in Stephenville.
