Councilor Felix

Councillor Felix expressed the following: Stephenville Airport Corporation

- "As Chair of finance committee, I have to speak to this motion as part of my due diligence. When I got elected to council it was with the intent that I would always make decision that I felt were in the best interest of taxpayers and that I would be transparent on the facts. I believe that the taxpayers need to be more informed on the facts as it relates to this further funding request for the Stephenville Airport Corporations (SAC).
 - 1. The first fact is that the Airport Corporation is an independently incorporated body that is solely responsible for the management, ownership and operations of the Stephenville Airport facility. Any decision to close or keep the airport open rest with this corporation and not our council.
 - 2. The SAC presented to council a strategic business and operational plan 2016-2019. The previous council invested \$750,000 of taxpayer money into this business plan which one of the four key goals was for the airport to become financially sustainable. In fact, the financial projected statements contained in the plan indicated sustainability of the airport by year 2019. This did not occur.

As chair of finance, I informed council that a sustainable annual grant for the airport of \$200 to \$250K was achievable given our financial position. This is something that I fully support.

Council operates on a budget of \$8.4 million dollars. Fixed costs consume \$7.6 million to operate our town. This leaves discretionary funding of approximately \$800K, which is all we have, to meet the needs of our taxpayers.

Since December 2018 and including future request council is currently aware of will have provided the airport corporation \$565K, which represents 70% of our discretionary fundina.

The level of funding coming from the taxpayers of our town is not sustainable. The \$100K request today was not budgeted for 2019 this along with any other additional funding for 2019 will place our budget in deficit.

4. The taxpayers of Stephenville risk not having other priorities in our town addressed; such as, road repairs, especially potholes, children's play grounds, kids splash pad, dog park, downtown improvements, business and community development investments and the continuation of supporting the many not for profit organizations that do tremendous work in our town. Considering all the facts, as chair of finance, I am voting NO against the motion because ir far exceeds the annual grant I support of \$200 to \$250K per year for continued funding to the Stephenville Airport.

The SAC should be seeking other avenues for funding and if this regional airport has value then other municipalities may want to consider making a contribution to the cause or even a go fund me campaign to find 1000 supports at \$100 each would yield a \$100K of funding.

If council approves this funding today there will be a responsibility to our taxpayers to outline a reasonable strategy to justify continuing using taxpayers money on an airport that provides limited flight services for its residents and limited cargo capacity for our business community without a legitimate plan in place.

Key Message: Stephenville taxpayers cannot afford to give the airport 70% of councils discretionary funding at the expense of other development priorities.

Councillor Hynes stated that he has met with the SAC Board and they are aware of the situation.

Deputy Mayor Fowlow stated that it is an important piece of infrastructure and that it is important to come up with a plan.

Mayor Rose commented that the Airport is the hub for air ambulance for four hospitals In the region, P.A.B., Burgeo, Stephenville and Corner Brook. It is important for the region and the provincial and federal government needs to step up. He also stated that the Airport needs new business plan and structure.

Councillor Aylward stated airport cannot close it is vital for Air Ambulance and will affect the hospitals ability to recruit physicians. It is important for our economy.

Mayor Rose

- Mayor Rose advised that the traffic lights at Queen Street and Prince Rupert Drive are well underway and should be completed shortly.
- He advised that the Town has a new piece of equipment called the Hippocampe, it's an innovative device that allow persons with

disabilities/mobility issues to get around and avail of the 16km of trails/beaches in the area.

Councillor Hynes

- stated that Colonial Evans passed away this week. He was the last Base Commander from the Ernest Harmon Air Base.
- commended Deborah Coughlin on the friendly invasion festival this summer. She has and continues to do a tremendous job at organizing this event and others throughout the community.
- He also acknowledged Colonial Clyde Russell who organized the Navy Ship visit this summer on an amazing job. He also stated that he is working on another event for next year.
