# **PROPOSED AMENDMENTS- TOWN OF STEPHENVILLE FENCING REGULATIONS**

Motion No. 18-242 Fowlow/Gibbon

That the recommendation of the Planning and Traffic Committee be accepted and the proposed amendments to the Town of Stephenville Fencing Regulations 1979, be adopted as follows:

Corner lots Fences can be a maximum of:

-0.9 metres (3 ft.) high:

- in the front yard
- within 1.5 metres (5 ft.) of the side lot line abutting a street, and

• within any driveway or corner visibility triangle including a neighbour's driveway.

-1.82 metres (6 ft.) high:

• provided they are set back a minimum of 1.5 metres (5 ft.) from the side lot line abutting a street

-2.4 metres (8 ft.) high:

• provided they are set back a minimum of 4.5 metres (15 ft.) from the side lot line abutting a street

- in the rear yard, and
- the interior side
