


Why Stephenville?

Who do I contact about starting a business in Stephenville?

Whether you are ready to make an application or want to discuss a development proposal, the Town of Stephenville welcomes the opportunity to talk in an informal and confidential setting. Our Municipal Services staff can provide information on the issues concerning the development of a specific site and the Town's requirements for the proposed development.

Economic Development staff can assist with statistics and market research material and provide contact information for the municipal, private, provincial, and federal funding sources.

What regulations apply to the start-up and operation of my business?

There are several regulations which the Town has adopted that apply to all business types:



Are there regulations that affect where my business can be located?

Yes, to establish a business on a specific property, you must be sure that the area is zoned for your business.

To find out if the business meets the zoning requirements of your property, you should contact the Planning Department.

What is Discretionary Use?

Discretionary use means any development considered on its own merits and circumstances and permitted in a particular zone only by resolution of Council and only in locations specified in such a resolution.

How do I register/apply to operate a business in Stephenville?

Applicants can obtain the necessary permit applications and fee information by contacting the Planning Department.

Each application form states the supporting documentation required, which applicants must submit along with their applications.

It is essential that the applicant also contact other agencies for their requirements.

How long will it take to receive a Business Permit and/or Building Permit?

A Business Permit and/or Building Permit (if required) cannot be issued until a review is received from relevant outside agencies. Town staff cannot comment on how long it will take to complete their assessment.

Are any other permits or approvals required?

Approvals and permits may be required for renovations, additions, and fences. Please get in touch with the Planning Department for more information.

08

Is a business tax charged for Commercial Businesses?

Yes, the Town of Stephenville charges property, water and sewer, and business taxes where applicable. Please see the Town website for the most up-to-date information and rates.

09

Can a Business Permit be revoked?

Yes, The Town of Stephenville can revoke a permit for various reasons, including failure by the holder to comply with relevant regulations or any condition attached to the permit or where the permit was issued in error or was issued based on incorrect information.
