Cancellation of Contribution Agreement with Stephenville Airport

Be it resolved to approve to provide the Stephenville Airport Corporation notification to terminate the Contribution Agreement that was approved by motion no. 23-84. As per Article 1.2 of the agreement on May 19, 2023 the Town of Stephenville will provide the 30 days notification to terminate the agreement.

Mayor Rose, as the sitting ex-officio member on the Stephenville Airport Board of Directors, provided an update on the transfer of the airport to the Dymond Group. He stated the airport was in bankruptcy for seventeen years, and this delayed the process. This past Monday: funds were transferred from the Dymond Group to a trust account with the Airport lawyers, for the purchase of the airport. Dymond has fulfilled the terms of the agreement and the obligations within, including paying off the line of credit, legal, GST, and severance, etc. He stated this is great news for the Town of Stephenville and the airport will start providing funds to the taxpayers of this town. He suggested the deed to transfer to come in short order.

Deputy Mayor Fowlow in response stated, it's an important day, that we waited for. The town will no longer need to financially support the airport but will instead see revenue from taxes and as business starts to happen.

Councillor Tiller sent congratulations to everyone involved in the sale of the airport and is looking forward to Greater NL Partnership fulfilling their promises made to the people of the region.
