# **NEW BUSINESS**

#### **Councillor White**

Requested an update on the hatchery, Mayor Rose stated council will receive an update on the expansion on Monday.

#### **Councillor Boland**

Councilor Boland requested an update on the Town water systems and wastewater. In response the Chief Administrative Officer, Colin Maddock stated the town is still receiving minimum support from the Town of Kippens until Well No. 1 is fixed. Next week Well No. 8B should produce another 100-200 gpm. He stated the town's water system is in good shape, and we will be in a position soon to be ready for growth. She asked for confirmation that the wells had little or no maintenance for a number of years, in response CAO stated the wells was last cleaned out in 2014 and also the sewage treatment plant is similar, with maintenance ongoing. Councillor Boland acknowledged an issue of needles and garbage being noticed on the beach and asked if this issue was related to the town's sewage treatment plant. The CAO noted once a year the sewer outfalls will clog and will

need to be cleaned and some solids will come through the system. The beach was searched for debris, but nothing was located as the tide would have removed any items. Our system captures the solids and it's disposed at waste management.

Mayor Rose acknowledged that the sewage treatment plant and Artisan Wells were a commitment made by great leadership shown by a past Mayor, Cec Stein and council and currently the towns sewage treatment plant is in full compliance with federal regulations.

#### Music Fest

The music fest that occurred last summer was not a town event, the SPCA held the event and hopes next summer another can be planned.

She acknowledged and attended the North American Indigenous games taking place in Halifax. The Newfoundland athletics are doing great, and she recognized that her daughter is competing in track and field.

Send condolences to the late family of Pixie Hynes, the Mayor stated she was 108 years old.

# **Mayor Rose**

He responded to a question from Councillor Boland, stating the Town did not raise property tax but rather reduced the mil rate from 7.4 to 7.2, no change in business mil rate, and eliminated the poll tax. However municipal assessments are provincial and outside of our control. CAO noted supplementary assessments from the municipal assessment agency occurred and values of homes increased, and the mil rate is applied.

He congratulated Jean House on the 50<sup>th</sup> anniversary of the seville singers. He also praised Deputy Mayor Susan Fowlow on her two solo performances.

#### Stephenville Theatre Festival.

He acknowledged Stephenville Theatre Festival 45<sup>th</sup> Anniversary, which is the longest professional theater group in the province. He noted the STF is a primer to Broadway for actors and actresses. He praised both shows he attended, Rock of Ages and the dinner theatre and gave recognition to the Board of Directors, Manager Ben Pittman, and the Artistic Director Heather Broaden for their great work. He encouraged everyone to go see a show.

Theres a Airforce memorial at the Legion, and he noted one plane that went down remains in Bay St. George and it's been told in the right conditions aircrafts upon approach can see the plane at the bottom. Theres a gentleman flying into Stephenville tomorrow whose father went down with that plane in 1953.

#### Councillor Tiller

Acknowledged he met a tourist and his wife whose father served here with the base. Once the base closed, they moved back to the states, and it was his first time back. We found someone who was able to remember the landmarks during the base era and he guided them to places from his childhood.

# Councillor Aylward

Acknowledged a change in what was known as Dr. McComiskey Clinic.

Two new doctors are starting soon at the BSG Medical Clinic

One Nurse Practitioner is not practicing at the emergency department.

We need to advocate to Health officials and Government that the current setting for BSG Medical Clinic is not sufficient for current staffing requirements.
