#### **NEW BUSINESS**

#### MAYOR ROSE

Mayor Rose stated the Town of Stephenville had two significant events this week. Carl Dymond and the Dymond group of companies officially purchased the airport. He recognized and applauded the previous and current councils that supported the airport and kept it open. He also commended the airport boards for their dedication, noting he was the first chair of the airport corporation dating back to 1999.

The mayor remarked he understands Carl Dymond and his investors are moving forward with their first investment into a new hanger, one for airport craft and one for equipment.

The second important event was World Energy received Crown Land approval, stating this is great news, this project is scaled at the single largest private investment in the history of Atlantic Canada with the expectations this project could "grow to become green energy hub of North America; that's how big it is. "It's approved up to 4 gigawatts. So, in scale, 1000 megawatts is 1 GW. Muskrat Falls is only 865 megawatts. 4 gigawatts is like 5 Muskrat Falls." The Investment is from European green investment firms. From SK, Eagle plant out of South Korea. John Risley, Gene Jabolis, Brendan Paddock. October 31, 2023 government will make the final decision on the environmental impact studies.

"A work camp will be established on 40 acres in town and will accommodate up to 2000 workers. Get ready, it's going to be busy times, but we must manage those busy times and we will work diligently with council and management and our community." And he recommended local businesses use every measure, every financial tool they can to ensure that they take advantage of what's coming because this is very, very significant. Stephenville may see its third economic boom.

Town clerk left meeting at 7:26pm and returned at 7:30pm, CAO was Acting Town Clerk during this time.

Our town is seeing movement; the airport is sold and will get busy with airlines in time; the Port of Stephenville is sold and has been busy since its takeover.

He acknowledged members of council is actively working in our community with Councillor Boland – Guadian Angels, Councillor Aylward – Hospital Foundation Councillor Hulan – Search and Rescue and Deputy Mayor Fowlow does a lot of work and assists with files.

He read a note he received from a visitor, Mr. Quinn, in which he thanked Mayor Rose for his wonderful experience and hospitality while visiting Stephenville. Mr. Quinn currently in his seventies, was only three years old when his father was in the aircraft that went down in Bay. St. George. The airport has a plaque and model of the plane that went down, and they say with the right weather conditions people have seen the plane at the bottom of the ocean.

He recognized and appreciated the work completed by the beautification committee this year.

#### **Deputy Mayor Fowlow**

She reminded citizens about back-to-school safety and being extra cautious when driving as more kids will be biking and walking to school.

#### Councillor Aywlard

She acknowledged council has received a petition from 85 residents of New Mexico Drive regarding the speed limit on that street, she noted a child was killed there in 1974 and the street was turned into one way. She stated the town is reviewing safety measures and speed bumps have been discussed.
