2. Unit shall not be a prototype and have a proven record of mechanical reliability.
3. Tenders which are incomplete, conditional, obscure or qualified may be rejected as invalid.
4. The equipment list in the Towns' specifications must be furnished whether or not included in the standard manufacturer's specifications.
5. The term "standard" is defined as that equipment listed or shown as standard equipment at no extra cost in the manufacturer's current publication.
6. Deviations from specifications must be noted with the bid proposal. Deviations will be considered informalities in bidding and may not be accepted by the Town.
7. In case of tie low bids, the Town of Stephenville reserves the right to use the most expedient means available to arrive at an award.

SUPPLEMENTARY CONDITIONS

1. Units offered under this tender shall be new, current year manufactured, standard production models or the latest design in current production, complete per the following specification or approved equal.
2. The design of the mechanical members shall be such that the stress imposed through normal shock loads at maximum engine torque shall not cause rupture or permanent deformation or undue wear on any member.
3. The bidder shall satisfy the purchasing official that he maintains a servicing branch in the Town of Stephenville capable of providing the necessary servicing and supply of parts for the machine offered, and with provisions for securing parts from the manufacturer within a reasonable length of time. All service and warranty work to be carried out in Stephenville.
4. Bidders must submit with their bid the latest printed specifications and advertising literature on the unit they propose to furnish.
5. Bidder shall supply one (1) operator's manual with each unit.
6. Bidder shall list on provided spaces any variations from, or exceptions to, the conditions and specifications of this bid. Deviations will be considered informalities in bidding which may or may not be accepted by the Town.
7. Equipment is to be completely serviced by the dealer before unit is delivered.
8. It is agreed that the units as bid will be delivered completed within ten (10) weeks of award and that failure to deliver within such period will be cause for cancellation of the purchase order. Delivery is to be made to the Public Works Garage, 56 Wisconsin Drive, Stephenville, Newfoundland.
9. Bidder shall submit with the bid, the terms, conditions, and cost of extended warranty options.
10. Supplied equipment must conform to all requirements of the Newfoundland Motor Vehicle Registration Act for Highway application.
