UNFINISHED BUSINESS

Mayor Rose

Mayor Rose highlighted some important events that took place in 2023:

- Sale of Port of Stephenville to Private Capital May 31, 2023
- Sale of the Stephenville Airport to Private Capital August 25, 2023 and the completion of LED Lighting system, worth three million dollars, federal government contributed two million, and Dymond group approximately one million.

Public Meeting of Council January 11th, 2024

- The Provincial government announced a \$40 Million contract to build a new collaborative care clinic in Stephenville.
- Stephenville Industrial Facility has been sold for 10 million dollars, with payments over the next eight years.
- Newfoundland Aboriginal Women's Network is continuing to construct a \$ 4 Million dollar Housing project.

Mayor Rose stated he is comfortable expressing council after three years in term has left the town in a better place. He acknowledged individuals have the right to complain about council and use social media platforms to address, however it is challenging when the information is inaccurate.

Mayor Rose acknowledged the council's support to lobby for Health Care and the Collaborative Clinic; with many meeting with health care officials including Premier Furey, Minister Haggie, Minister Osborne, Sister Davis, Dr. Parfrey.

NEW BUSINESS

Mayor Rose acknowledged the resignation of Councillor Boland and Councillor Tiller. He thanked them for their service and contributions to the council. Councillor Aylward and Councillor White also thanked them and wished them well. A by-election will be held, and the date will be forthcoming. Anyone interested must be a resident of Stephenville, taxes must be paid and must have time to commit to council.

Mayor Rose stated the mil rate for residential property did not change in the 2024 budget, it remained at 7.2 mils, there was a slight increase of .2 mils for Business Tax. Residents' assessments increased, which would increase their bill, this is outside the control of council. After 30 years steady, the water and sewer rates increased. The increased cost of operating, infrastructure expansions to water/sewer and maintenance on infrastructure all are considered when reviewing the budget. He thanked staff, management and council for a really good budget.
