Mayor Rose

Welcomes Candace Simon as Deputy Chief Administrative Officer. Candace noted that she is happy to be part of the team, very enthusiastic about the potential of Stephenville to grow and although coming in on the cusp of a by-election, it has been a positive experience and she looks forward to working with the incredible team and helping the team and town grow.

Mayor Rose spoke for public comments that were in support of World Energy. He referred to Economic Development Manager of the town who is originally from the Orkney Islands in Scotland for size comparison, stating that the Orkney Islands would be roughly the same geographical size as the Port au Port Peninsula. The Islands however, have a population of approximately 20,000 people and roughly 800 wind turbines, and the Port au Port Peninsula has approximately 3,000 people and will only have roughly 124 wind turbines. Mayor Rose stated that Canada has been behind the times in sustainable energy as the Orkney Islands have had wind turbines now for approximately 40 years. March 20, 2024 is the final deadline for citizens who wish to submit comments in support of the project.

Public Meeting of Council February 22nd, 2024

Mayor Rose attended the Chamber of Commerce meeting recently and noted that Billy Hynes who comes with a great recreational background, spoke on the newly formed Bay St. George Sport Recognition group. He plans to gather and research the history and achievements of athletes from different areas and showcase them, as well as memorabilia. Some of the athletes from this area recognized at the Chamber meeting were Gerry Boland, Don Cormier, AI Hancock and Katrina Roxon for their accomplishments and contribution to sport. Councillor Laura Aylward congratulated Billy Hynes and his son Stephen on taking on this initiative and said they already have a facebook page started but are looking at having a plaque or some sort of recognition placed at the Dome. Deputy Mayor Fowlow said that she also thinks this is a wonderful idea and could expand to be similar to a museum. In previous years she recalled seeing some old plaques and trophies in storage at the Middle School which had belonged to previous schools that no longer exist such as L.S. Eddy, Integrated High and Bishop O'Reilly high, so hopes that they might still be there and available for use by the Sport Recognition group.

Mayor Rose gave reference to the Map on the wall in chambers and spoke on the expansion plans for the Town of Stephenville. Currently the town has 90 km in sewer lines and 110 km of water lines. We should infill as much as we can or go up. This would be the area of Queen Street, Gallant Street, Hansen Highway and West Street. The expansion will be done in three stages. Stage one will include the areas around Oregon Drive and Utah Drive where there is a large amount of vacant land. They will work with developers, put out RFP's to determine the scope of development. Likely will be apartments and small condos developed which will hopefully allow for approximately 2,000 additional residents. Stage two will be the area of Gallant Street extension to the subdivision at the end of Queen Steet which would accommodate an additional 5,000 people. The time frame for competition of Stages 1 and 2 is approximately 5 to 15 years. Stage three is Igloo Road to route 460. This would be the biggest expansion and would include tiny homes, commercial subdivisions and town houses and would accommodate approximately 8,000 residents. A lot of the land to be developed is Town of Stephenville land so will count as revenue.

Councillor Aylward

She is pleased with the newsletter received from Nigel Pike regarding the bike lanes and would like to commend his dedication and work that he has put into this as a volunteer. She also acknowledged the new communication person that will be starting a new position with the town. She feels it will be an asset to getting information out and keeping residents properly informed.

Councillor Aylward also brought up the need for a proper divided highway from Port aux Basques to St. John's. She said that Minister John Abbott recently spoke on the paving and divided highway for the Central and Eastern parts of the province, and she would like for people from this area to start speaking out about the need for the same on the West Coast.

A meeting regarding health care with the hospital foundation board and the new CAO of the Health services NL will be taking place at the Days inn and Councillor Aylward will be attending as a member of the board. In conclusion she would like to congratulate all the candidates running in the by-election and remind them to keep it clean and keep it positive and good luck.

Public Meeting of Council February 22nd, 2024 Deputy Mayor Fowlow

She wanted to update on the sport of Pickleball. It is growing in the Town of Stephenville and two weekends ago the lunchtime group started a new learn to play rec league in the evenings. They hosted a fun tournament with 16 teams which was approximately 40 new people. They have a facebook site as well and have plans to expand.

Mayor Rose noted that sometimes things are discussed in privileged meetings, until they are brought to a public meeting where they are adopted, passed or defeated. There are procedures followed on financial items, grants in lieu of taxes that require different amounts of votes to pass. In the case of a grant in lieu of taxes, a business who has plans for significant growth may be granted a reduced amount over a 24 month period, however at the end of that agreement period if the goals and objectives haven't been met, than council has the right to cancel the tax agreement. Dealings with stake holders should remain private until it goes to a public meeting.
