Councillors O'Brien mentioned that himself and fellow Councillors Hynes, Fowlow and White attended the Accessibility and Inclusion Public Forum the night previous to the Council meeting and commended the staff on the work that was being done.

Councillor Aylward would like to have the dog regulations sent out to Councillors. There is a problem in the town with dogs running loose and the Municipal officer has to deal with that issue quite frequently.
