CODE OF CONDUCT – Conflict of Interest

25-86 Moved by Councillor O'Brien, Seconded by Councillor Roberts

Mayor Rose declared conflict of Interest and left the council table. Deputy Mayor Fowlow assumed the role as chair.

With respect to a complaint of a conflict of interest against Mayor Tom Rose made pursuant to the *Municipal Conduct Act*, SNL 2021, c M-20.01 <u>WHEREAS:</u>

- A. The Town of Stephenville received a formal complaint from a member of the public (the "Complaint") alleging that Mayor Tom Rose had engaged in actions while in a conflict of interest, in violation of the *Municipal Conduct Act*;
- B. Council engaged an external investigator to investigate the Complaint;
- C. The external investigator prepared an Investigation Report dated March 6, 2025. The Investigation Report clarified the scope of the Complaint as being in respect of an alleged conflict of interest in violation of section 6 of the *Municipal Conduct Act*.
- D. The Investigation Report was considered by Council at a closed meeting held on March 18, 2025;
- E. The Respondent, Mayor Tom Rose, was heard before Council in response to the Investigation Report on March 18, 2025;
- F. Mayor Tom Rose has requested that his written response, which was provided to Council in response to the Investigation Report, should be tabled at a public meeting of Council;

COUNCIL HAS DETERMINED THAT:

- 1. The Investigation Report dated March 6, 2025, including the recommendations of the Investigator, is accepted by Council.
- 2. The Town Council finds that Mayor Tom Rose acted in a conflict of interest with respect to the matters described in the Investigation Report dated March 6, 2025, pursuant to section 8(10)(b) of the *Municipal Conduct Act*.
- 3. The Town Council finds that the Mayor has acted in a conflict of interest through inadvertence or a genuine error in judgment within the meaning of section 9(2) of the Act. Mayor Rose's seat on Council is therefore not vacated.
- 4. Council has discretion to determine the appropriate sanction within the meaning of section 9(2) of the *Municipal Conduct Act*. Council has determined that no sanction against Mayor Rose will be imposed in connection with the Complaint.
- 5. The Investigation Report dated March 6, 2025 is hereby tabled at a public meeting in keeping with section 8(11) of the *Municipal Conduct Act*.

Now on this 3rd day of April 2025, Be it Resolved that the Town Council of the Town of Stephenville hereby dismisses the complaint of a conflict of interest against Mayor Rose; declines to vacate his seat on Council and imposes no sanction against him.

Question was called – council sought clarification with statement made in No. 1 – "The Investigation Report dated March 6, 2025, including the recommendations of the Investigator, is accepted by Council", and motion brought forward to dismiss the compliant.

UNFINISHED BUSINESS

Mayor Rose

He noted the town has received complaints from residents regarding vehicle parking on Main Street, particularly in restricted areas, creating visibility and safety concerns for drivers entering or exiting Main Street. It was suggested that increased diligence from the municipal enforcement officer may be necessary to address the issue.

He noted the impact of new U.S. auto tariffs on Canada, particularly in Ontario and Quebec, with potential retaliatory measures expected. This may encourage more Canadians to purchase domestically made vehicles.

NEW BUSINESS

Spring Clean-Up

The period of May 5 – May 9, has been designated as curbside Spring Clean- Up in the Town of Stephenville. This year the program will be different, Town Trucks will pick up debris and refuse on the same day as residents regular scheduled garbage day, there will be no return trips for missed items. Weekly regular household garbage and recyclables must be separated from the other debris.

Drop Off - Residents of Stephenville can also dispose of clean up materials from April 28th – May 2 at the Town of Stephenville Public Works Depot located at 56 Wisconsin Drive from 8:30 am to 4:00 pm.

A full guide to clean up week will be available on social media and will also be mailed to residents in the coming weeks.

Councillor Aylward

A complaint was received from an elderly resident regarding a neighbor repeatedly disposing of garbage on her property. Councillor O'Brien confirmed receiving a similar complaint, noting that garbage also appears to be falling over a nearby bank. The CAO advised that while staff can review the situation for potential illegal dumping, the matter may ultimately be civil in nature.

Chief Administrative Officer

He stated in conversation with the Director of Municipal Government, there may be changes in the provincial government budget that will help municipalities address issues related to codes and legislation. Also, the department is drafting the required documents under the new act for municipalities to use, which will alleviate financial costs.
