# **CODE OF CONDUCT**

Mayor Rose declared conflict of Interest and left the council table. Deputy Mayor Fowlow assumed the role as chair.

With respect to a complaint of a conflict of interest against Mayor Tom Rose made pursuant to the *Municipal Conduct Act*, SNL 2021, c M-20.01

### WHEREAS:

- A. The Town of Stephenville received a formal complaint from a member of the public (the "Complaint") alleging that Mayor Tom Rose had engaged in actions while in a conflict of interest, in violation of the *Municipal Conduct Act*;
- B. Council engaged an external investigator to investigate the Complaint;
- C. The external investigator prepared an Investigation Report dated March 6,

2025. The Investigation Report clarified the scope of the Complaint as being in respect of an alleged conflict of interest in violation of section 6 of the *Municipal Conduct Act*.

- D. The Investigation Report was considered by Council at a closed meeting held on March 18, 2025;
- E. The Respondent, Mayor Tom Rose, was heard before Council in response to the Investigation Report on March 18, 2025;
- F. Mayor Tom Rose has requested that his written response, which was provided to Council in response to the Investigation Report, should be tabled at a public meeting of Council;

### COUNCIL HAS DETERMINED THAT:

- 1. The Investigation Report dated March 6, 2025, including the recommendations of the Investigator, is accepted by Council.
- 2. The Town Council finds that Mayor Tom Rose acted in a conflict of interest with respect to the matters described in the Investigation Report dated March 6, 2025, pursuant to section 8(10)(b) of the *Municipal Conduct Act*.
- 3. The Town Council finds that the Mayor has acted in a conflict of interest through inadvertence or a genuine error in judgment within the meaning of section 9(2) of the Act. Mayor Rose's seat on Council is therefore not vacated.
- 4. Council has discretion to determine the appropriate sanction within the meaning of section 9(2) of the *Municipal Conduct Act*. Council has determined that no sanction against Mayor Rose will be imposed in connection with the Complaint.
- 5. The Investigation Report dated March 6, 2025 is hereby tabled at a public meeting in keeping with section 8(11) of the *Municipal Conduct Act*.

NOW on this 17<sup>th</sup> day of April 2025, BE IT RESOLVED THAT the Town Council of the Town of Stephenville hereby finds Mayor Rose in a conflict of interest; declines to vacate his seat on Council, and imposes no sanction against him.

### **NEW BUSINESS**

### Housing Infrastructure Vision Session

Councillor Hynes

He stated he attended the housing infrastructure vision session and noted it was a successful event; it provided an opportunity to meet with individuals that can support future projects.

Mayor Rose

He gave recognition to the management team for the successful housing infrastructure event. He stated the event was well attended by community members, and provincial representatives were also present. The event gave an opportunity for the participants to share their visions for housing development, and it was interesting to see the different styles.

### **Chief Administrator Officer**

There was representation from Municipalities Newfoundland and Labrador, as they are participating in and supporting the town through couple initiatives. First with housing needs analysis, this assessment is underway with Memorial University, and they are also seeking input from our local community members. Municipalities Newfoundland and Labrador (MNL) initiative with housing support officers are supporting municipalities to utilize unused government programs. About \$100 million was available but was left untapped due to various reasons, approximately \$38 million has been now approved. The housing needs assessment once completed will be utilized to apply for funding through Federation of Canadian Municipalities, Canadian Home Infrastructure Fund, and applicable provincial funds. He commended staff on the successful event and recognized local sponsors and MNL who contributed to the event. Sponsors will be acknowledged and posted on the town's website.

He addressed concerns raised about the use of asphalt millings from the downtown Main Street construction project. The town, within the tender specification, requested the first opportunity to use the milling for community projects. The milling is the property of the contractor and it's their disposal if the town doesn't use it. The milling will be used to benefit the community by improving the gravel roads and walking/biking trails and future projects. Additionally, the milling has not been placed in watershed areas, this has been investigated and confirmed. The Director of Public Works, Engineering and Asset Management stated the milling will be used on gravel roads, behind Acadian Village on Minnesota Drive, Newtown Road, Hillier Ave, Burtons Place and Ridgeview Ave.

Councillor O'Brien confirmed the milling is not being placed on the mayor's property, but rather on a nearby property and water resources were consulted and raised no concerns.

### Mayor Rose

He acknowledged he attended the College of the North Atlantic Scholarship ceremony, where tens of thousands of dollars in scholarships were awarded; the town provided a \$500 scholarship, while World Energy GH2 provided three \$ 2500.00 scholarships to the top three academic performers for the wind technician program. It was also great to see the strong presence of international students.

GDP

He made a comparison for GDP - 60% of the GDP of Canada comes from Ontario. Alberta- 15%. Newfoundland Labrador per capita produces more GDP for our country in any province in Canada.

Cultural space – we are working on the placement of four wigwams to represent four directions and we are working collaboratively with the cultural foundation to enhance the space with storyboards and focusing on accessibility.

Community Event – Easter Egg Hunt Century 21 will be hosting easter egg hunt at Blanche Brook Park on April 19 between 2:00-4:00 pm
