#### **Important Notice – Hydrant Flushing Program**

The Town will be conducting a routine fire hydrant flushing program starting Tuesday, May 20, and will ongoing for the next few weeks. Flushing will begin in the Base area and will continue throughout the town. While flushing takes place in specific areas, residents and businesses across the town may still experience temporary water discoloration and reduced water pressure. These effects are normal and should be brief. If water discoloration occurs, we recommend running an outdoor tap such as the one used for a garden hose, until the water runs clear. If you don't have an outdoor tap, run a cold water tap inside your home instead. We appreciate your understanding as we carry out this important maintenance to ensure water quality and system reliability. Thank you for your understanding and cooperation.

#### Town Podcast

We will soon be launching an online town podcast in order to keep our residents better informed about what's happening in our community. We plan to provide updates on different departments and event at the town level, feature town historians, leaders of community organizations, nonprofit groups, local business owners, and organizers of special events happening around town.

He attended Grenfell's convention ceremony whereby two residents from our region were recognized. Katarin Roxon received an Honorary degree for her role in sports and Robert Cormier received Honorary degree for his passion and dedication to preserving and promoting the French language; both gave impressionable speeches.

Acknowledged the work of the Community, Economic, and Industrial Development Manager who has secured federal funding as part of BNZ Cohort partnership. The town is the only community in the province working with sixteen municipalities across the country in partnership to develop building standards for net zero by 2030

#### Main Street Reconstruction

He inquired if an audit can be completed on the sidewalks to ensure any cracks are repaired.

CAO responded to an inquiry by Councillor Aylward, he noted the contractor bid in the project based on their standard work schedule: ten days of twelve hours work followed by four days off. This approach was factored into the project costs and schedule and adding work into the four days off would by costly in overtime and would increase the project cost overall and travel time is included in these days. The public feedback is appreciated, and efforts are being made to educate them on this standard construction practice. Similar scheduling is expected for Rose Avenue reconstruction.

Recommended the Town host Geology Symposium Summit in September 2026 and invite university students across Canada to view the towns unique 300-million-year-old fossil forest.

He referenced Stephenville is the first Canadian Town to be mentioned on a podcast from Germany for Global Covenant of Mayors for Climate and Energy. The 37 minute podcast is reached globally, and it highlighted Stephenville innovation around green energy and reducing carbon footprint; including the town's Effluent System, Carbon Credits, leak detection scans and solar panels.

# **Chief Administrative Officer**

He discussed a plan to streamline the approval process for change orders related to municipal capital works projects. Management intends to propose a delegation of authority to allow staff to approve certain change orders without returning to the council for approval, as long as they fall within the pre-approval financial limits. This new process aims to address changes in a timely matter.

# **Councillor Roberts**

As council representative he provided an update for the Aquatic Centre, stating financials are stable, but there are concerns about aging pool equipment that will need to be replaced. The pool received a government grant for approximately \$9900 to offer free swims, and this has generated new revenue due to increased participation in swim classes and memberships.

He noted the Town of Stephenville provides a \$160,000 grant to the pool but also pays for the insurance and provides in-kind maintenance. The manager of the pool is expected to provide a presentation to the finance committee in the fall.

Mayor Rose stated he would expect the capital expenditure required for the pool to be supported by the regional group.
