## **Purpose**

The Town of Stephenville invites Expressions of Interest (EOI) from qualified parties for the purchase or long-term lease of the Stephenville Industrial Facility. The Town is seeking submissions that align with its strategic goal of supporting job creation, industrial growth, and sustainable economic development.

The purpose of the EOI is to identify parties with interest, experience, and capacity to operate or redevelop the facility. Responses will inform potential next phase of a formal Request for Proposals (RFP) or negotiated agreement.

## **Development Compliance and Implementation**

All proposals must be in full compliance with Provincial, Federal, and Municipal regulations governing land development and environmental protection. The successful respondent will be responsible for ensuring that the proposed development project carefully follows all regulations throughout all phases of implementation.

## **Facility Overview**

- Location: 1 Connecticut Drive, Stephenville, NL.
- Total Building Size: 101,640 sq. ft.
- Lot Size: Approx. 7.1 acres.
- Zoning: Industrial.

## **Key Features**

- Two hangar doors (13m x 13m).
- Five new overhead doors.
- Six electrical distribution stations (up to 600V); 15,000V transformers.
- large laydown area.
- Crane-equipped bays (30m x 90m with 30-ton remote-operated cranes).
- Office space and washrooms.
- Upgraded HVAC, fire protection, CCTV, and LED lighting.
- 15 km to Trans-Canada Highway and Route 460.

## **Submission Requirements**

Interested parties should submit a written Expression of Interest that includes the following:

- Business Name & Contact Info.
- Company Profile (years in operation, ownership, key personnel).
- Experience in industrial facility use or redevelopment.
- Intended Use of the property (sale or lease, industrial activity, etc.).
- Preliminary Capital Investment Plan (if any).
- Potential Economic Benefits (e.g., job creation, training, spin-offs).
- Preferred Transaction Model (purchase or lease).

## **Evaluation Process**

Submissions will be reviewed by the Town based on:

- Alignment with economic development objectives.
- Proponent qualifications and financial capacity.
- Potential for job creation and investment.

Shortlisted respondents may be invited to participate in further discussions or submit a detailed proposal.
