Councillor Roberts asked was there any update on the building that was once the Women's Penitentiary. CAO Ramsay said that during meetings in St. John's earlier that week, he attempted to meet with the Department of Transportation but was unsuccessful, so will do a follow up with the Minister's office. Mayor Rose said there are formal request letters on file. He mentioned that the building is quite dilapidated, and the biggest concern is the safety of people who work and live in the area. With each windstorm, pieces of the building break off and fly around. Deputy Mayor Fowlow suggested setting a timeline and keep on top of it and on top of everyone's to do list.

He said he has been getting a lot of compliments on the signs. There were a couple of signs that had grammatical errors that needed fixing. He said that once the new signs are all up, the old signs might be available for purchase through an auction.

# **Councillor Aylward**

She noted the meeting with NLHS officials went well. There was an OB/GYN online for the meeting and there is currently 4 in the region right now. She noted there is a former resident who wants to come home and work. She is graduating in 2026 and will be here in August for a wedding, so would be a good time to set up a meeting. She also mentioned that our recently hired surgeon is now living in Corner Brook and has also joined a fee for service team in there. He is currently only coming out here part time. Councillor Aylward said we need to lobby for another surgeon who will live here in case an emergency surgery is ever needed.

## **Chief Administrative Officer**

He advised that during his time in St. John's he met with two Assistant Deputy Ministers from the Department of Health. They were aware of the meeting that was held between Council and NLHS. They spoke briefly on OB/GYN, Surgery and also the future Long Term Care Facility. There are selection sites currently being looked at and the Department of Industry, Energy and Technology will be contacting the Town for more information.

He also spoke on recruitment of Doctors, Specialists and Medical Personnel and there are many applications being submitted from Towns throughout the Province. The Government Officials noted that daycare seems to be the key element in the recruiting process and having daycare services near to the hospital is higher on the list or priorities than money. He said this is something we need to move on and prioritize along with wastewater management.

# **Mayor Rose**

He said new industries and existing industries have higher demands for acute care and we need to start fighting for our services now. These projects will help us lobby for additional services and will bring young families to our area.
