The mayor recommended to defer to allow the request to be processed through the community grant program in compliance with established procedures, acknowledging this was different than past practice. Deputy CAO confirmed the request should follow the same process required of other community groups and is committed to setting up a meeting with the BIA to review the MOU. Councillor Roberts and Councillor Hynes agreed, it is a disappointment that this concern was not addressed at the committee meeting and the recommendation brought forward has been changed within a couple days.
